## 3.0 ELIGIBILITY CRITERIA

The interested bidders/service providers are required to submit the following:

- a. Evidence of Certificate of Incorporation issued by the Corporate Affairs Commission (CAC) including Form CAC 1.1 or CAC2 and CAC7;
- b. Evidence of Company's Income Tax Clearance Certificate for the last three (3) years valid till 31<sup>st</sup> December, 2024; with minimum average annual turnover as stated in the bid documents;
- c. Evidence of Pension Clearance Certificate valid till 31<sup>st</sup> December, 2024 (this requirement is only applicable to bidders whose number of staff is 15 and above);
- d. Evidence of Industrial Training Fund (ITF) Compliance Certificate valid till  $31^{st}$  December, 2024 (this requirement is only applicable to bidders whose number of staff is 5 and above or the bidder's annual turnover is  $\frac{1}{2}$  20m and above);
- e. Evidence of Nigeria Social Insurance Trust Fund (NSITF) Clearance Certificate valid till 31st December, 2024;
- f. Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/12/2024 or valid Certificate issued by BPP.

- g. Sworn Affidavit:
  - disclosing whether or not any officer of the relevant committees of the Nigerian Institute of Leather and Science Technology, Zaria or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
  - that no Director has been convicted in any Country for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter;
  - that the Company is not in receivership, the subject of any form of insolvency or bankruptcy proceedings or the subject of any form of winding up petition or proceedings;
  - That the company does not have existing loan or financial liability with a bank, other financial institution or third party that is classified as doubtful, non-performance, bad or whose repayment portion has been outstanding for the last four (4) months;
- h. Company's Audited Accounts for the last three (3) years 2021, 2022 & 2023, duly acknowledged by the Federal Inland Revenue Service (FIRS);
- i. Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- j. Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications such as COREN, QSRBN, ARCON, CORBON etc.;
- k. Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards,
- 1. Evidence of Firm's current registration with relevant regulatory professional body(ies) such as (COREN, QSRBN, ARCON, CORBON etc);
- m. Training: Evidence of Firms current registration with relevant regulatory professional body (ies) such as Center for Management Development;
- n. For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Clearance Certificate, ITF Compliance Certificate, NSITF Clearance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner);
- o. All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

# 4.0 SUBMISSION OF EXPRESSION OF INTEREST DOCUMENTS

Prospective Firms should submit Expression of Interest for each of the lot desired, two (2) hard copies packaged in sealed envelopes and clearly marked as "Expression of Interest" and addressed to the Director General/Chief Executive Officer, NILEST indicating the project title and name of bidder inscribed on the left corner of the envelope while confidential is marked at the right corner of the envelope and submit in the Tender Box in the office of the Head of Procurement Unit of the Agency's National Headquarters at Sokoto Road, almost opposite the Main Gate of Ahmadu Bello University, Samaru, Zaria, Kaduna State not later than **10:00am on Monday 22<sup>nd</sup> April, 2024**.
